The preparer must give you a copy of Form 7200 in addition to the copy to be filed with the IRS. If you're a paid preparer, enter your Preparer Tax Identification Number (PTIN) in the space provided. Include your complete address. If you work for a firm, enter the firm's name and the EIN of the firm.

Form 1040 or 1040-SR (2019), lines 1-7b (includes Schedule 1, lines 1-9). However, do not include any income shown on these lines from Form(s) W-2. In columns (b) and (c), allocate joint income, such as interest earned on a joint bank account, as you determine. Be sure to allocate all income shown on the joint return.

INSTRUCTIONS FOR FILING A SMALL CLAIMS CASE

On the employee's Form W-2, show the payment as social security wages (box 3) and Medicare wages and tips (box 5) and the social security and Medicare taxes withheld in boxes 4 and 6. Do not show the payment in box 1.

Any excess credit must be claimed as a refund using Form 8849, Claim for Refund of Excise Taxes, and Schedule 6 (Form 8849), Other Claims. Also use Schedule 6 (Form 8849) to make a claim for an overpayment due to a mistake in tax liability previously reported on Form 2290. See When to make a claim, later.

File for unemployment in the first week that you lose your job or have your hours reduced. Your claim begins on the Sunday of the week you became unemployed. If you filed for unemployment within the last 52 weeks (12 months) and have not exhausted your benefits, you must reopen your claim to restart your benefits. COVID-19 Temporary Exceptions
